## MEMORANDUM CIRCULAR

**TO: ALL HEADS OF DEPARTMENTS, BUREAUS, OFFICES AND AGENCIES OF THE NATIONAL AND LOCAL GOVERNMENTS INCLUDING GOVERNMENT-OWNED OR CONTROLLED CORPORATIONS; STATE COLLEGES AND UNIVERSITIES; EMPLOYEE ASSOCIATIONS OR UNIONS**

**SUBJECT: PARTICIPATION IN THE NATIONAL PUBLIC SECTOR LABOR-MANAGEMENT CONGRESS**

In line with the efforts to strengthen the Public Sector Unionism and make public sector unions/associations as effective and efficient institutions which can contribute in improving and providing quality public service delivery, a National Public Sector Labor-Management Congress will be held on November 22 and 23, 2001 at the Manila Midtown Hotel, Ermita, Manila. The Congress aims to provide a venue to:

1. Assess the status of Public Sector Labor-Management Relations;
2. Revisit the role of government workers in providing quality service to the public;
3. Gather insights and learning from experiences and innovative practices shared by experts and co-workers;
4. Draw up meaningful policy recommendations to strengthen the collaboration and partnerships between and among government workers and executives in improving service delivery system.
5. Election of union representatives to the PSLMC.


Considering the significance of this event, heads of agencies are enjoined to send participants representing the employees' association or union and participants representing the management. Participants are authorized to attend the Congress on official business.

The registration fee is One Thousand Eight Hundred Pesos (P1,800.00) per participant, inclusive of lunch, snacks, and materials. All payments in cheque must be addressed to the Civil Service Commission. Because of limited accommodation, acceptance of participants will be on a first come first serve basis.

Pre-registration date is on October 12, 2001 while confirmation of participation should be made on or before October 31, 2001.

Attached is a registration form which can be reproduced as well as a list of hostels/places of accommodation where participants from the provinces can check in at a reasonable price.
