Amendment No. 1 to Annexes A, B and C of MC 11, s. 1996

RESOLUTION NO. 968343

WHEREAS, the Commission in its Resolution No. 96-4906 dated August 5, 1996 classified the various positions in government which require skills not measurable by paper and pencil examination into Category I, Category II, and Category III;


WHEREAS, the Commission issued the corresponding Memorandum Circular No.11, s. 1996 relative to these new categories of positions including the necessary implementing policies;

WHEREAS, further review of the duties and responsibilities of certain positions not included in the above-mentioned categories but covered by the first level requiring subprofessional eligibility, reveals that merit and fitness for appointment thereto cannot actually be measured through paper and pencil test but through actual work performance ;

NOW, THEREFORE, the Commission hereby **RESOLVES** to amend the list of positions under Annexes A, B and C of MC 11, s. 1996 to include the additional positions listed in the attached annex..

This Resolution shall take effect after fifteen (15) days from publication in a newspaper of general circulation.
