**GUIDELINES AND OPERATING PROCEDURES
FOR THE EQUITABLE DISTRIBUTION
OF THE LOCAL SCHOLARSHIP
PROGRAM (LSP) BENEFITS**

The following is the revised Guidelines and Operating Procedures for the equitable distribution of scholarship grants on the Local Scholarship Program (LSP):

AWARD OF LSP GRANT

- Each region shall be allotted a number of scholarship grants based on the number of provinces/legislative districts a region has, as follows:

- ❑ To realize the allocated slots for the province/city, the cut-off score shall be adjusted based on the slots available. For example, if Baguio City has 10 slots, the Civil Service Regional Office (CSRO) will get the first 10 examinees obtaining the highest score in Baguio City to qualify for the interview phase of the LSP assessment process.
- ❑ The Office for Recruitment, Examination and Placement (OREP), CSC, therefore, shall simply rank the examinees per province/city and region wide.
- ❑ In case there are no examinees for a given province/city, or in case of waivers of grantees, the CSRO shall allocate the slots for that particular province/city to the examinees in the poorer province.
- ❑ In extreme cases, where there are less examinees than the number of targetted scholars in a particular region, the Commission, through the Human Resource Development Office (HRDO), shall allocate the quota to other regions, prioritizing the more disadvantaged region/province. ■
