RESOLUTION

WHEREAS, pursuant to Executive Order No. 292, otherwise known as the "Administrative Code of 1987" and its implementing Rules, and Executive Order No. 508, series of 1992, as amended by Executive Order No. 77, series of 1993, the Civil Service Commission administers the annual Search for Outstanding Public Officials and Employees where the Presidential or *Lingkod Bayan* Award is conferred;

WHEREAS, the Special Committee on Presidential or *Lingkod Bayan* and Civil Service Commission *Pagasa* Awards for 2011 has been constituted, and after thorough evaluation and rigid deliberations on the nominations, the Committee has finally recommended **ten (10) finalists to be conferred the Presidential or *Lingkod Bayan* Award;**

WHEREAS, of the ten (10) Presidential or *Lingkod Bayan* Award finalists selected by the Special Committee on Presidential or *Lingkod Bayan* and Civil Service Commission *Pagasa* Awards for 2011, seven (7) are individuals and three (3) belong to the group category;

WHEREAS, pursuant to the above-cited laws and the implementing rules and policies on the Honor Awards Program, the Presidential or *Lingkod Bayan* Awardees are given cash rewards, gold-gilded medallions, Presidential plaques, and are provided with a two-night/three-day hotel accommodation, among other incentives;

- D. To approve the grant of a two-night/three-day (triple-sharing) hotel accommodation for the group members conferred the Presidential or *Lingkod Bayan* award.


