BAC Resolution Recommending Shortlisted Consultants and Approval by the Head of the Procuring Entity for the Project "Consultancy Services for the Coffee Table Book on Civil Service Programs and Innovations in ASEAN"

RESOLUTION NO. 2017-09

WHEREAS, the Civil Service Commission, through its Bids and Awards Committee (BAC) advertised the procurement announcement/Request for Expression of Interest (REI) of the project "**Consultancy Services for the Coffee Table Book on Civil Service Programs and Innovations in ASEAN**" in the newspaper of nationwide general circulation on March 23, 2017 and posted the same in the PhilGEPS and CSC Websites, and conspicuous place in the premises of the CSC-Central Office continuously for at least seven (7) days;

WHEREAS, three (3) prospective bidders, i.e., (1) *Studio 5 Designs, Inc;* (2) *Mode Matrix Manila, Inc.;* and (3) *EON, Inc.*, submitted letters of intent and eligibility requirements; all of them were found **eligible** during the Eligibility Checking on March 28, 2017;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184, shortlisting among the eligible consultants was conducted on March 28, 2017;

WHEREAS, the CSC-BAC with the assistance of the BAC-Technical Working Group (TWG) Team-B and End-User Office (Commission Secretariat and Liaison Office) conducted shortlisting procedures to the prospective bidders, and rated them in accordance with the criteria for shortlisting. 


