

INVITATION TO BID FOR THE PROCUREMENT OF SECURITY SERVICES FOR CSC RO IV

- 1. The Civil Service Commission Regional Office IV, through the General Appropriations Act (GAA) intends to apply the sum of One Million One Hundred Fifty Three Thousand Four Hundred Thirty Seven Pesos and 60/100 (Php 1,153,437.60) being the ABC to payments under the contract for the Procurement of Security Services for CSC RO IV with project reference number CSCROIV-GF-2023-072. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Civil Service Commission Regional Office IV now invites bids for the above Procurement Project. Delivery of the services is required by April 1, 2024 to March 31, 2025. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-3. discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from Civil Service Commission Regional Office IV and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 25 to November 22, 2023 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos only (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through e-mail.
- 6. The Civil Service Commission Regional Office IV will hold a **Pre-Bid Conference** on November 7, 2023 at 1:30 PM through hybrid setup. Video conferencing or webcasting shall be open prospective bidders Teams to via MS (https://tinyurl.com/PreBid2024CSCROIVSecurity).

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **November 22, 2023 strictly at 8:30 AM**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. **Bid opening** shall be on **November 22, 2023 at 9:00 AM** through hybrid setup. Video conferencing or webcasting shall be open to prospective bidders via MS Teams (https://tinyurl.com/Opening2024CSCROIVSecurity). Bids will be opened in the presence of the bidders' representatives who hoose to attend the activity.
- 10. The Civil Service Commission Regional Office IV reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
