PSLMC RESOLUTION

WHEREAS, on March 16, 2020, Proclamation No. 929, s. 2020, was issued by the Office of the President, Declaring A State of Calamity Throughout the Philippines Due to Corona Virus Disease 2019 (COVID-19);

WHEREAS, pursuant to Presidential Proclamation No. 922 Declaring A State of Public Health Emergency Through the Philippines, and imposition of Enhanced Community Quarantine (ECQ) over the entire Luzon, Congress enacted Republic Act No. 11469 or the "Bayanihan to Heal as One Act" which declared the entire country under a state of national emergency due to the rise of confirmed cases of COVID-19;

WHEREAS, Congress thereafter enacted Republic Act No. 11494 or the "Bayanihan 2 Act" which continued the declaration of a state of national emergency over the entire country in order to control the spread of COVID-19 and establish mechanisms to reduce the adverse effect of the pandemic to our economy and society;

WHEREAS, the Council is cognizant that during a state of public health calamity, the welfare, health, and safety of employees and the general public are of paramount importance;

WHEREAS, the Council recognizes that the above limitations due to the COVID – 19 outbreak and quarantine restrictions have affected the timely registration of the Collective Registration Agreements (CNAs) in accordance with PSLMC Resolution No. 2, s. 2007, which requires registration thereof to the Civil Service Commission (CSC) within ninety (90) days from execution, either personally or by mail.

NOW, THEREFORE, the Council **RESOLVES**, to relax the 90-day requirement to register the approved and ratified CNAs for the duration and

implementation of the State of Calamity declared by the President due to COVID-19 pandemic until thirty (30) days after its lifting.


This Resolution shall take effect after fifteen (15) days from the date of publication in the Official Gazette or in a newspaper of general circulation.
