The Philippine Librarians Association, Inc. (PLAI) in partnership with the National Commission for Culture and the Arts (NCCA) through the National Committee on Library and Information Services (NCLIS) and the National Library of the Philippines (NLP), will hold its annual National Congress with the theme "Working Together: Sustainability, Opportunity, Adaptability, Resiliency (SOAR)" on 22-25 November 2022 at the Iloilo Convention Center, Iloilo City, Philippines.

This year's Congress aims to:

- Describe how libraries of today translate changing needs and services into functional, inspiring and adaptable spaces for the future, especially considering the pandemic;
- library resilience in the face of disruptions caused outbreaks/pandemic; and highlight examples of library resilience during these unprecedented times, including evidence of library roles in providing research assistance to clients:
- Demonstrate significant initiatives, sustainability, and adaptability measures taken by libraries which can serve as examples for others to meet postlockdown needs.

Plenary sessions and parallel sessions will be conducted to discuss topics relevant to the different types of libraries (i.e., academic, public, school, and special). A General Assembly will also be held to present updates and provide a venue for discussion of concerns relating to the Association and the profession in general.
